RELEASE AND WAIVER OF LIABILITY

In consideration for participating in the SGBC Fire Ant Festival Find the Fire Ant Contest I agree the following:

1. **Permission to Use Likeness; Publicity Release.** To the fullest extent permitted by applicable law, I grant to Sponsor and its subsidiaries and affiliates, irrevocably and in perpetuity, the right of publicity, including without limitation, the right to use, adapt, reproduce, distribute and publicly display my name, image, likenesses, identity and identifiable aspects, in whole or in part, throughout the universe, for any marketing, promotion, or commercial purposes determined in the sole discretion of Sponsor and/or its subsidiaries or affiliates without payment or reimbursement of any kind to me.
